5. **Last Date of Receipt of Application as per Format Given at our website.** Application as per requisite format along with self attested photocopies of testimonial in support of Education Qualification and work Experience will be submitted to OIC, ECHS Cell Stn HQ Chandimandir, District - Panchkula (Haryana) - 134107 by **05 Mar 2025** upto 2 PM in duplicate. Any application received after due date will not be accepted. Incomplete applications will not be accepted.

6. **Interview Date, Timing & Venue.** On scrutiny of application, short listed candidate will be called for interview and intimated through email/SMS/telephonically. Candidate must reach Station Headquarter Chandimandir at 0900 hrs on the date of interview to be held between 0930 hrs to 1430 hrs. Candidates must bring all the original Certificate/mark sheets/degree of 10th/matric, 10+2 & graduation/post graduation/diploma/course, work experience and discharge book, PPO, service records and two passport size colour photographs at the time of interview. No TA/DA will be admissible. Only candidates meeting the Qualitative Requirements may apply.

7. **On Job Training (OJT) for OIC, Med Oftrs, Med Specialist, Gynecologist and Dental Oftrs at ECHS Polyclinics.** Minimum 10 days handing/taking over between the above mentioned appointments at polyclinics would be carried out for smooth functioning of the establishment. The selected individuals for the said appointments will have to carry out 10 days On Job Training (OJT) and obtain a certificate from OIC Polyclinic before signing the contract (Memorandum of Agreement). This duration of OJT will remain unpaid and counted as mandatory before assuming charge as a contractual employee.
