1. Recruitment for the above post will be purely on the contractual basis for 3 years. Initially in future any claim for the regularisation of the post will not be entertained. Place of posting will be fixed at CID Ranchi.
2. Initially the contractual appointment will be for three years and thereafter the appropriate authority/committee will consider further extension only on the basis of satisfactory performance as per Government rules.
3. As per the rule of recruitment on contractual basis vide letter no./4569 dated-05.07.2002, of Finance department, Jharkhand Govt, the case of non-extension after three year appointment will be considered terminated.
4. If any person wants to resign, he/she can leave after giving two month's notice to the controlling officer or he/she will have to forfeit two months remuneration. The person cannot claim pensionary benefits.
5. Controlling officer at his discretion may terminate the contract after giving one month notice in lieu without assigning any reason for termination.
6. Selected candidate will have to sign Non-disclosure Agreement (NDA) with the department before joining.
