- The candidates must be a Graduate with minimum age of 22 years and maximum age of 35 years and having basic knowledge of English language and Computer/IT applications. Two years working experience in the same field shall be preferred.

 to the outsourced skilled/Graduate worker. Total salary to be paid to a DEO will be as per actual
 attendance in RCT.
- The working hours of DEOs will be 8 hours per day from 09.30 to 18.00 hrs with half an hour lunch break from 13.30, to 14.00 hrs on all working days.
